GAUGE THAT DIDN'T TELL THE FULL STORY GARRY MION

This story starts out with a road trip out to Carefree to attend Corvettes and Coffee, a cruise-in held on the first Sunday of the month in front of Jimmy and Val Sheehan's patio Store. It was a normal drive out as far as I can remember, noticing nothing out of the ordinary. After having breakfast at Local Johnny's, I headed back home. At about Ray and the Loop 101, I glanced down at the dash and noticed something wasn't quite right. Well, the picture at right tells the story about what I saw.

Now, I'm traveling at about a very conservative 74mph (well—conversative relative to many other drivers). The first question I had was "did this just happen?" I should have immediately pulled over, but things didn't quite add up. Why weren't there any warning lights or messages? The engine was running fine—temperature was normal, there were no abnormal noises to be heard, no other indications that would suggest the engine had no oil pressure..

I decided to proceed on the freeway, at less speed, getting off at Arizona Ave and stopping at the Quick Stop. First thought was to check the oil level. It was a little low, but within tollerances. I purchased a quart of synthetic anyway and topped it off, but there was no change to the oil pressure gauge. What I did notice, however, was the gauge would go through its normal start procedure of reading full 80lbs, then back to zero, but then it would go up slightly and stay there—similar to what you see in the picture above. I concluded this to mean that perhaps there was at least some oil pressure present. I sat in the car and decided to do some web searches to see if this problem may have been seen by others. Well, it has, and in a significant majority of the situations it was not a failure of the oil pump, but rather the oil pressure sensor. I concluded that this was most likely my problem, and proceeded to drive home without incident.

That afternoon I did more research, and ordered a new oil pressure sensor that would be delivered in two days. That would give me enough time to figure out how to actually go about replacing it. A few YouTube searches later, I was looking at something that ranged from <u>removing</u> the entire intake manifold, to <u>cutting a hole</u> in the firewall just under the wiper valley cover (turns out this process is likely only good for C5s). The arrow in the picture at right shows the location of the oil pressure switch.

Once the part arrived I began the process of possibly having to remove the entire intake, but about a quarter of the way into it I began to think that with the right socket, I might only have to go as far as removing the fuel rails and intake cover to have just enough access to get to the sensor—which happened to be the case.



Removing the fuel rails is not hard, just time consuming as I wanted to make sure I didn't ruin any sealing O-rings along the way (original to the car, now at 177K miles). I also didn't want to get gas all over the place, so I spent time stuffing paper towels around the fuel nozzles to catch what comes out of the rail. Once the fuel rail is out of the way, the black intake cover comes off and there is much more room to navigate the socket into position. I could actually see the top of the sensor and the electrical connection.

The picture below right shows the socket setup I used. The socket itself was just deep enough to ensure that it would catch the hex body of the sensor, but short enough to allow it to be slipped in and

the over the sensors electrical connector.

Once the sensor was out, I was pleased to see how clean the area where the sensor sits was.

There is actually a filter that sits below the sensor, and in some of the YouTube videos I was shocked how it dirty it looked. I was confident I wasn't going to need to replace mine.



When it came to putting the new sensor in, I put some tape around the hex body so it would not fall out when I tried to navigate the tight opening. I had no idea how I would have been able to fish out the sensor if it did indeed fall out. You'll notice that the sensor comes thread sealant pre-applied. A nice touch I thought. I did order an AC Delco OEM replacement. There are other vendors that provide an equivalent sensor, however.



I thought for sure I was going to spend a good deal of time fighting to get the sensor threads to start properly, but it went right in on the first try. After replacing the fuel rail and fuel injector connectors, it was time to see if this indeed fixed the problem. I started the engine, and after about 15 seconds the oil pressure gauge had not moved off zero. I immediately shut the engine off. Poop. What did this mean? I started the engine again, and after about another 20 seconds the oil pressure gauge started to move, slowly at first, but ultimately it reached a normal operating pressure. Phew! The '08 will continue to see more miles.


